### **3. Treasurer's annual report including Presentation and Adoption of Accounts (AGM Item)**

- I. **Auditor Richard Cox has signed off the accounts:** to 28<sup>th</sup> February 2018. KL proposed adoption of these accounts, seconded by JR. Accounts adopted.
- II. **ECA is Financially healthy.**

### **1. Matters Arising from previous Minutes**

- iii. **Pavement damage by the George:** will need road to be closed so waiting until there are sufficient issues to justify this

- v. **LHR 3<sup>rd</sup> runway:** RBWM continues to challenge/object. Will focus on conditions to be attached for example night flying in hot weather (open windows). Malcolm A reported that the press explains the RBWM contribution to the Judicial review.
- vi. **Rubbish:** action committee met with and did walk-round with Tony Robinson. PE, LO, ML and others have been gathering evidence where the road sweeper is not always doing what he should. Action has much improved, though there is a risk that this is temporary, as has happened before. DB has written to properties on the High Street – copy of the letter is on the ECA website.

## 2. RBWM Councillor Matters

- i. **Boundary review:** announcement is due 10<sup>th</sup> July. There is optimism that Eton will be with Eton Wick and Castle (Windsor).
- ii. **Public slipway by Flaming Cow:** ownership looking likely to be RBWM
- iii. **Meadow Lane car park:** 6-month trial to dedicate 13 spaces along the Meadow Lane edge to resident only spaces (permit L). Red lines and clear signage will be installed. Thanks to PE for providing the statistics to justify the 6-month trial. Still some bins to be removed. Will not be sufficient space for electric charging points where recycling bins and frame are being removed, so will provide motorcycle parking instead in this space. New parking machines will be in by the end of this year. Solar-powered belly bins will be provided – they compress litter then send a message to Veolia when full.

- i. **Vote due Thursday 11<sup>th</sup> July:** please vote on this; traders don't have a vote unless they are on the electoral register for this area, which is unfortunate.

## 4. Chairman's Report

- i. **Eton Action List:** is on the ECA website and is reviewed monthly involving relevant people from RBWM. Remainder of gulley replacements are being installed currently. Thank you to Cllr A.

ML reports his business switching to Virgin has been worth doing though not straight-forward, but Virgin unlikely to provide this for residents unless there is sufficient demand  
**Action:** discuss mobile phone signal options with CT and with AP-R RR

- v. **Finding the Brook:** hopes to complete this year; proposal for PE and Brook Team to remove the vetter (inflatable balloon to block water flow) when the brook is officially re-opened.
