1. Welcome and Apologies - RR

- i. The Chair welcomed all attendees and noted the apologies as listed.
- ii. Special thanks were given to the Thames Valley Police team for attending to present current crime and safety updates.

2. TVP Update - BW

- i. Between September and October 2025, there were 13 recorded incidents in Eton, including thefts of laptops, wallets and sunglasses from parked vehicles.
- ii. Criminal damage was reported in the High Street where plant pots were broken; similar issues occurred in Eton Wick with two ball-bearing impacts on property windows.

- iii. Burglary at Atherton Court remains under forensic investigation.
- iv. Anti-social behaviour (ASB) continues around the Brocas particularly in Summer, during end of exams and school leaving times; incidents are mainly caused by visitors, not fair operators.
- v. Community feedback prioritises Anti-Social Behaviour, wrong way cycling down the High Street and problems caused by the might-time economy
- vi. Reports of slingshot and catapult use harming wildlife continue; residents are urged not to confront perpetrators but to report details. DW had been shot at (reported 14th August). Residents also reported gunfire near Crown Farm and the Jubilee River; longterm clay-pigeon activity was noted in the area.

vii. Cllr MHP is working with Matthew Barber (TVP and Crime Commissioner) on a PSPO to allow confiscation of catapults but our council are reported to be "dragging their heels"

Action: e-mail or write to Cllr Mark Wilson to support a PSPO to tackle catapults and slingshots ALL of us

- viii. Problems on Brocas Street and on the Brocas are at their worst just after school exams. TVP do try to patrol to move people on but we ask for a more pro-active approach. TVP are setting up a new unit ASB team. It may be an option to apply for them to target the area on known trouble dates
- ix. E-scooters and cycling the wrong way on the High Street remain under enforcement, with monthly operations planned.
- x. A new PCSO (Danny Colville) joins the team; Street Angels will assist in Eton during weekend night-time hours.
- xi. Residents were encouraged to use the TVP online contact form for non-urgent matters and provide as much detail as possible.

Action: TVP – Continue monthly enforcement operations and maintain visible patrols in Eton and Eton Wick.

Action: Residents – Report ASB and slingshot incidents with specific times and descriptions.

- i. The Cockpit planning approval was noted with conditions eg CIL which has already been paid.
- ii. Car parking: RBWM to trial 25% discounted rates between October-November 2025 and January-March 2026 to support local businesses.

iv. School lights: Still to be confirmed operational; further checks planned. **Action:** Porny Governor MW – Follow up on school safety lighting.

4. Chair's Report - RR

- i. High Street shops: 61 High Street (former Beaubelle) becoming an estate agents; 52A High Street (antiques) remains vacant; Cappadocia (former Eton Mess) have stopped responding to e-mails; Windsor Brides residential was refused; Eton Stationers to become a dentist; 109 former Venture upper floors now let, retail needs repair before letting; Gilbey's remains for sale at £1.8 million.
- ii. Christmas lights: Funding discussions ongoing working with ETC; installations planned for end October for 13th November lights switch on event.
- iii. Community issues: Residents reported wildlife harm (poisoned foxes) and misuse of catapults near the college grounds. see section 2.
- iv. Signage and street maintenance: Broken and faded signs reported to Cllr Wilson for action.

- xiii. Location of leaving real Christmas trees on Tuesday 6th January not yet decided

- xiv. Pub walk was planned for this Sunday 12th October but few have responded to date resulting in decision to delay.
- xv. Huge thanks to Stewart Rogers for an awesome Pub quiz!
- xvi. Eton Premier Store is now a Londis
- xvii. Diverts have been cut in Brocas and South Meadow causing Safety concerns. Both are College privately owned but it is known that College require a request which they may not accept from potential metal detectorists.

5. Treasurer's Report - SR

- i. Finances remain healthy with stable reserves and new donations received.
- ii. Christmas lighting and community events will require further contributions. More donations wanted any amounts welcome. Details in 9th October Shout Out newsletter
- iii. Donation tiers (£20–£175) were discussed and promoted for inclusivity. Form says £60-£175 which is what traders are asked for.

- i. We need at least two additional CCTVs. Including the cost of connecting to the Tinkers Lane monitoring dept we have a grant which will fund one. We plan to install this near the Watermans Arms and seek further funding for a second camera in Meadow Lane. Council are considering whether to also install dummy cameras.
- ii. Pavilion refurbishment works commenced.
- iii. Thanks to PE who has identified many plots of land which two hundred years ago were prevented from being enclosed. Looking for ideas on how to celebrate the "Glorious 200"
